# MILITARY AIR AUTHORIZED CHECK BAGGAGE

- MILITARY ARE AUTHORIZED TO CHECK 4 BAGS
- DOD/DA CIVILIANS ARE AUTHORIZED TO CHECK 3 BAGS
- CONTRACTORS ARE AUTHORIZED TO CHECK 2 BAGS



# MILITARY AIR AUTHORIZED CHECK BAGGAGE CONTINUED

- EACH BAG MUST BE **NO** LARGER THAN A STANDARD SIZE ARMY ISSUED DUFFLE BAG
- BAGS CAN **NOT** WEIGH MORE THAN 70LBS EACH
- BAGS WITH WHEELS ARE **NOT** AUTHORIZED
- BAGS WITH WHEELS REMOVED ARE **NOT** AUTHORIZED.

# MILITARY AIR AUTHORIZED CARRY ON BAGS

- ALL FLYERS ARE AUTHORIZED TO CARRY ON 1 PERSONAL BAG.
- THE BAG MUST FIT WITHIN THE AUTHORIZED DEMENSIONS.
- LAPTOP BAG IS COUNTED AS YOUR 1 CARRY ON BAG
- LAPTOPS MAY BE REMOVED FROM CARRY ON TO MEET REQUIRED DEMENSIONS



# CARRY ON DEMENSIONS



- CARRY ON – **LIMIT ONE**

MUST FIT INSIDE THE CARRY ON BOX

8" D x 21" W x 16" H





# EXCEPTION TO POLICY

- ANY EXCEPTIONS TO THE ABOVE MILITARY AIR BAGGAGE RULES MUST BE APPROVED BY THE FORT BENNING PERSONNEL ASSISTANT POINT.
- The CRC DOES NOT HAVE AUTHORITY TO APPROVE ANY BAGGAGE EXCEPTION TO POLICIES.
- EXCEPTION TO POLICIES MUST BE SUBMITTED TO THE DEPLOYMENT COMPANY NO LATER THAN THE CLOSE OF BUSINESS TUESDAY OF THE PROCESSING WEEK.
- EXCEPTION TO POLICY FOR ANY TYPE OF WHEELED BAGGAGE WILL BE DISAPPROVED.
