

## MEMORANDUM FOR TRAINERS

SUBJECT: Range Bulletin: 07-15 for Period 17 MAY 15-11 JULY 15

1. **Range Operations:**a. **Weekly firing schedule/hours of support currently in-place.**

- Radio Room will run 24-7, except for Federal Holidays published in Table 2, below.
- No firing past 2400 hours....may be able to flex work schedules to longer periods, however will require minimum of 6-weeks' notice...all OT will be approved case-by-case and by exception with Units paying OT up front...just because OT funding is available, does not mean manpower is as well. Remember, we still need to allow travel time for Range Personnel, so some training may have to be shut-down earlier than 2400 hours depending on employee shift schedules and travel time required to get back to the rear to clock out.
- Saturday firing priority will only be RC Units, OSUT/IET BRM POI training and will only be allowed during the day up until 2000 hours (2 8-hr shifts), no night time firing allowed. Priority will go to the RC Units for training, however cannot exceed Saturday capability.
- No big bullet range firing is allowed on weekends.
- **Sunday** and **Holiday** "Live Firing (includes SIM Rds)" or "High Risk" training **is not** currently authorized on the installation. Exceptions to this policy will require DPTMS approval and OT funding costs may apply for support purposes.

b. **Ammo Substitution:** Ensure all double check any ammo substitutions that the ASP may be issuing against the approved ammunition sheets within your range packets. Remember this is an OIC/RSO responsibility to ensure you are firing authorized munitions IAW the packet. In the past we have seen where High Explosive (HE) ammo has been substituted for other ammunition which has resulted in unauthorized ammunition being fired on some ranges, some which has caused issues with DU restriction violations.



c. **RCW Checks in the A20 Impact Area:** Currently we have the following RCW checks scheduled for the A-20 impact area.

- 16-17 May 15
- 23-24 May 15
- 30-31 May 15

d. **Malone Complex Range Support:** Effective 20 April 2015, 316 CAV will no longer be supporting any of the Malone Complex ranges with Soldier support. Units using the facilities will need to ensure they have trained individuals to run the towers for their training needs. Affected ranges are as follows: Malone: 2, 7, 9, 11, 14, 15, 16, 17, 18 and Porter Range.

e. **WCLS Funding Cuts:** Effective 1 May 15 the Army has cut funding to the Warfighter Focus Contract that has now impacted the DMPRC, CACTF facilities and Malone 2 as far as on-site support goes. These current impacts are phase 1 with a phase 2 plan already in motion that will trim support down even further, if it happens. See embedded file below for the actual impacts for each area.

### **Basic Rules are as follows:**

- 1) Unit will schedule this facility by floor level, to include rooftop IAW current RFMSS scheduling rules in place.
- 2) Unit will be required to pick up keys at range operations for this facility prior to training event.
- 3) Unit will be required to get and opening and closing codes from Range Operations Fire Desk.
- 4) Unit will be required to return the key to Range Operations immediately after termination of training event.
- 5) Cleanup and police of the facility will be the Units responsibility.

i. **Range Walks/Leaders Recon requirements.** Units requesting to do a range walk/Leaders Recon of ranges/facilities are required to do the following. A RFMSS request will now need to be generated and approved for all terrain walks on the installation.

- If required, coordinate a minimum of 6-weeks in advance with appropriate range support team that you will need support from via RFMSS range request.
- Coordinate a minimum of 72-hours in advance with Using Unit or Sponsoring Unit for range/facility you will need.
- Coordinate a minimum of 24-hours in advance with Range Operations for range/facility you will need.
- On the morning of the range visit the Unit POC must call into the radio room via radio before going onto the range/facility with number of personnel and distance required down range for this visit.
- Upon completion of this visit, Unit POC must call back into the radio room and clear them off the range/training facility.

NOTE: Communications with Alpha Base (radio room) must be maintained throughout the visit.

j. **OSCAR Area Zero Range Packet Changes:** We have been directed to modify all OSCAR Area Zero Range packets and pull all events out of the packets except the "zero" portion of these packets. It seems we have been violating Environmental agreements and Federal laws that were put in place with the Biological Assessment (BA) that was part of the BRAC study done in 2005. There is currently a new BA underway that is reviewing these type training requirements for the OSCAR area ranges which if approved in the future will again allow us to put these events (CQM, Reflexive Fire, etc.) back into these packets for execution. Make sure all Units now look at their actual training requirements on these OSCAR area Zero Ranges and if you are

needing anything other than "ZERO" events, you will have to go to either the Malone or Alpha Complexes for these training requirements. Updated OSCAR area Zero Range packets will be posted to the Range Operations SharePoint Site first thing in the morning. The packets have now been updated and placed on the SharePoint site with new numbers assigned as shown below. Ensure all use these packet numbers when submitting RFMSS requests for these facilities or the requests will be denied.

k. **Ammunition and Explosives (A&E) Amnesty Program:** See the embedded document below for the MCoE policy that provides all personnel an amnesty opportunity to return ammunition or explosives to ensure maximum recovery of military A&E items found outside the supply system without penalty or reprisal.

l. **Instrumented Shoot Houses:** Pyrotechnics, grenade simulators, flash bangs, etc, of any kind are not allowed in the Buchanan instrumented shoot house as they will damage the equipment. On the other shoot houses that do not have this technology (Brann, Booker, Farnsworth), it is permissible to use these type training enablers as long as it is approved in the packets and it is requested on your RFMSS request.

m. **Red Lock Replacement:** Range Division has now started replacing all old red locks on all range gates with the new locks being black in color. The old red locks will remain on the gates until 31 May 2015. This does not apply to the force protection locks on the exterior gates as they are controlled by DES. Organizations/Units need to request the amount of new keys needed and identify a POC to sign for the new keys. Contractors that may work on the installation may contact Mr. Archie directly to sign for keys. POC for this action is Mr. Ernest Archie, 545-9428.

n. **New Post Safety staffing procedures for packets/safety risk management worksheets for any waiver actions.** New Post Safety policy now requires all work going to them will have a Fort Benning Form 25-52-1-R-E cover sheet which will need to be signed off on by Range Operations or they will not accept it. It must also be staffed through the Unit's Safety Officer and Master Gunner before it comes to Range Operations. This is driven by Units who have tried to send actions multiple directions before the plan is complete, sometimes with major concept adjustments to which they need to see for their review and approval process.

o. **Air Space Scheduling Requirements:** Procedures for requesting airspace have now changed. Units will be required to request all air space within RFMSS and must annotate the following information as shown in this example in the communication tab of the RFMSS request form. When coordinating with the Air Field Units will be required to bring a copy of the approved RFMSS request with them.

- **DATE:** 1 MAR 15 (each day must be annotated unless all days are exactly alike)
- **START TIME:** 08:00 (Eastern time, see note above)
- **END TIME:** 18:00 (Eastern time, see note above)
- **UNIT/AGENCY:** BAC 1/507th (unit is executing mission/agency is sponsor at Fort Benning)
- **POC & TEL:** SFC EAMES (706) 545-1868 (POC must be able to make short notice decisions on changes/revisions)
- **TYPE OPS:** CARP (short description, expand description in RMKS)
- **MSN ALT:** 2000 (highest altitude required for the duration of the mission)
- **NO. & TYPE A/C:** 3 / C-130 or C-17 (multiple types can be expanded in RMKS)
- **PZ/LZ:** KLSF (FOB, FSB, launch point, staging area, etc.)
- **DZ/LZ:** FRYAR DZ (ultimate destination in the FTBGA reservation, multiples expand in RMKS)
- **RMKS:** HALO jump after BAC jump from 1200 - 1300 @ 12500FT (limit to 200 characters), air box by compartments for unmanned flights, etc...

v. **Zero Target POCs:** Units needing zero targets will need to contact Mr. Ronnie Williams, 545-5677 for Alpha Area and Malone Ranges and Sergeant First Class Schmeiser, 544-7272 (BRM team number) or RP Support Team 706-676-4009 for the Oscar Area Ranges. Ensure this is done in advance (usually the day before) of actual training event(s) as same day requests may not be able to be supported along with normal mission requirements.

w. **Selby CACTF Scheduling:** Effective immediately all Units scheduling Selby CACTF or the Residential District will have to identify on their RFMSS request exactly what building they want to use for their training requirements IAW embedded pdf maps below. A PowerPoint file (CACTF Floor Plans) has also been placed on the Range Operations SharePoint Site under the Work Center and on the Rng Ops Website for use in determining building numbers as well as showing the individual floor layouts within each building which may come in handy when planning training. We are now in the process of creating a new one for the Residential District that will be posted in the near future for use by all.



x. **Big Gun/Kilo Area Range Scheduling/Coordination Requirements:** All units wanting to occupy & train on Brooks, Cactus, Carmouche, DMPRC, Ruth, Hastings, Terry Demo, K-36 Ranger Objective and Ware ranges, all indirect firing points or any Air Missions into the K-15 impact area will have to follow the procedures outlined below. Units will not be able to occupy any of these ranges prior to 0530 on the day of training, unless coordination is made well in advance for personnel support. Make sure when you request these type facilities that you have a day at the end of your firing exercise set aside for range clearance, which must be done in the day light hours.

- Ensure event and facility needed is locked on the Range Operations Big Gun Calendar
- Submit RFMSS request for date & times needed with a day-by-day detailed gun line.

- Conduct face-to-face final coordination with Mr. Hattaway, 545-3010 for all ranges except the DMPRC and Terry Demo, Mr. Cribb, 626-2678 is the POC for the DMPRC, and Mr. Williams (706) 545-5677 is the POC for Terry demo. Coordination is required NLT 7-days in advance from event start time (NLT 6-weeks out if overtime is needed). Due to range division manpower shortages you may run into any/all of the following, so ensure you plan ahead for any training/certification needs your Unit may require to ensure mission success in these dire times. Tower Operators will have to ensure towers are powered down daily when mission is complete and Units are self-running a range.

- Request/change is asked for too late as work schedule are already published, however OT may be able to be applied if manpower if available. The DMPRC even though contractor supported cannot have any changes under the two week time frame that may affect work schedules. We are required by contract to contractor a minimum of 2-weeks' notice to work schedule adjustments and OT cannot be applied here. No available tower operators. No range personnel to prep ranges, day or night. No range personnel to repair malfunctions or troubleshoot, day or night. No moving targets will be available when Range Division support is not in place.

Recommend all keep an eye on these schedules/routes and inform all Units operating in and around them to be aware of these convoys, as these are large vehicles carrying oversized loads to and from training facilities/ranges on the installation and we need to keep all safe. All HETS movements along the northern installation boundary hardball road that goes from Ruth to Hastings needs to be coordinated in advance. Remember, the Unit is responsible for scheduling HETS delivery/pickup and de-conflicting routes/timelines with other Units and Safety patrol if gate access is needed. 

iv. **Buchanan Zero Range Closure:** Buchanan Zero Range is now complete and waiver is approved for full use of 5.56mm – 7.62mm on the flat range.

v. **Burroughs Range Redesign/Construction:** Actions are underway to upgrade Burroughs Range for new long range Sniper requirements, and we are waiting on range specifics from the Unit before proceeding any further. Currently all targetry has been removed from this range, so the facility is effectively shut-down for all users with the exception of the Sniper School. Current actions underway are listed below. POC for this action is Mr. Ernest Archie, 545-9428.

When complete they will notify us so that we can finalize the installation and test all systems to ensure they are working and issue them the remaining equipment to run these targets. A new “Standard” range packet has been completed for this range and all other packets are now void. The new packet number is 10-2-14 with an indefinite expiration date.

ix. **Concord/Fergusson OP Update:** Firing line clearance is now complete. We are requesting assistance from Units to do some machinegun or main gun firing on this facility to trim back some downrange undergrowth to fully open this range back up again for mortar firing as well as other live fire events.

Current list of events that are still needed to bring up the Ferguson Range and lower Strip area back to full use is as follows.


