NIPR Account / In-Processing

1. **In-Process with S2:** The SAAR requires S2 to validate your security clearance before your account is created. NIPR account holders do not require a clearance but Denied, Revoked, No Determination Made, Foreign National, and other JPAS status entries may delay / hinder receiving an account, especially for BLC.
2. **ATCTS:** <https://atc.us.army.mil>
 - **AC Unit:** Training & Doctrine Command-->Maneuver Center of Excellence - Fort Moore(MCoE)-->US Army Armor School (USAARMS)-->316th CAV BDE--
 - **Signal Command Unit:** 7th Signal Command (Theater)-Fort Eisenhower-->93rd Signal Brigade (93d Sig Bde)-- Southeast Regional Network Enterprise Center Director-Fort Stewart-->Installation_Fort Moore, GA-->Network Enterprise Center-Fort Moore(NEC-MOOR)-->Maneuver Center of Excellence - Fort Moore(MCoE)-->US Army Armor School (USAARMS)-->316th CAV BDE--
 - This is where S6 validates your training and paperwork
3. **MilConnect \DEPO Entitlements:** <https://idco.dmdc.osd.mil/idco/>
 - **Sign in** and go to “**Update work contact info (GAL)**”, then click on “**MIL**” tab
 - Update the following, making sure to press “**Submit**” at the very bottom when finished
 - **Duty Organization** with “**United States Army**”
 - **Duty Sub Organization** with “**----TRADOC Armor School**”
 - **Duty Location** with “**Fort Moore**”
 - **Sign into DEPO** search the user by DOD ID and issue TRADOC license by availability. This will authorize the user to utilize their O365.
4. **DoD Cyber Awareness Challenge Training 2024:** <https://cs.signal.army.mil/> - *Annual requirement*
 - Click on “**Proceed to EAMS-A Login**” in the center of the page to log in
 - Click on “**Take Training**” under DOD Cyber Awareness Training to be directed to the training.
 - **BDE S6** only accept training verified through Fort Eisenhower Cyber Center (Link above)
 - This training can be completed on a visitor account or with assistance from unit supervisor.
5. **Army IT User Agreement:** *Annual requirement*
 - You must digitally sign the Army IT user agreement the same day you complete Cyber Awareness challenge. (Reference: DA PAM 25-2-6, Chapter 6-2, pg 4, 5)
 - Read through the AUP, then sign with your **Digital Signature**.
 - The Army IT user agreement is found right after you complete the **Cyber Awareness Challenge**.
6. **DD2875 System Authorization Access Request (SAAR):**
 - Fill out with a supervisor according
 - Once completed email to BDE S6 for review and submission
7. **Account Request:** Once a user has submitted all required documentation please refrain from logging in as this may prolong the creation process. Ensure that contact information is current as this will be the means of communication to inform once accounts are created.
