Duties:

Develops and recommends a program, including annual and five-year plans, for small sales of timber products and for free use of forest products.

Analyzes conditions in areas affected by drought, insects, disease, wind damage or fire.

Makes recommendations to treat or salvage timber through sales.

Plans and performs the field reconnaissance to collect data and appraises the products.

Analyzes environmental impacts and prepares written environmental assessment reports.

Determines method of sale and special sale requirements and assembles contract package.

Forest:

The Shasta-Trinity National Forest, located in north central California, is the largest national forest in California and provides high quality fish and wildlife habitat. It is comprised of 2.1 million acres ranging in elevation from 1,000 feet to 14,162 feet at the summit of Mt. Shasta. This forest encompasses five wilderness areas, hundreds of mountain lakes and more than 6,000 miles of streams and rivers. In addition, there are wild and scenic rivers, national trails and scenic byways and a National Recreation Area. For further information on the forest, please see

Community:

The South Fork Management Unit has a large variety of terrain and ecosystems that provide for a wide range of recreational opportunities. It encompasses over 590,000 acres, two wilderness areas and three major streams from the primary watersheds within the area; the South Fork of the Trinity River, Hayfork Creek and Beegum Creek. This Management Unit has offices in the town of Hayfork and Platina which are about 33 miles apart. Hayfork, California is a small rural community with a population of approximately 2,500 people. It is located about 60 miles west of Redding at an elevation of 2,300 feet. Hayfork has churches, stores, a medical clinic, and schools up to and including high school. Housing costs are approximately \$200,000 for a 3 Bedroom/2 Bath house and rentals average \$700/month. The Hayfork area offers a wide variety of outdoor recreational opportunities in a rural setting.
