Army Career Skills Program (CSP) Opportunity
Law Enforcement Information Systems Specialist (GS-7/9/11)
U.S. Customs and Border Protection (CBP)
U.S. Border Patrol (USBP) – Rio Grande Valley**

McAllen (TX), Edinburg (TX), and Olmitos (TX).

MAJOR DUTIES AND RESPONSIBILITIES

Intelligence gathering/analysis – Creates intelligence reports based on extrapolated data, research and analysis that is used by Border Patrol Agents to predict, detect, deter, and apprehend terrorists, terrorist related weapons, migrants, human smugglers, illicit drugs and other contraband from entering or attempting to enter the United States. Utilizes law enforcement databases, video/remote sensor data and geospatial information to collect and analyze tactical intelligence to produce reports impacting real time enforcement operations within the Agency and with other law enforcement agencies. Independently analyzes actionable information during specific events that involve officer safety. Results of reports are relayed to Border Patrol Agents in real time and used in summary data analysis. 25%

Video/Sensor Analysis – Independently analyzes tactical surveillance video and imagery in conjunction with sensor alerts and other resources to detect and identify threats and incursions entering the U.S. and relays that information to agents in real time. Incumbent prepares forensic evidence (audio and video) for court, establishes chain of custody, and testifies in court on behalf of the government explaining information conveyed to the field on surveillance activity, sensor alarms and database searches. 25%

GIS analysis - Provides agents with rapid access to USBP historical activity data (e.g., apprehensions, seizures, Significant Incident Reports (SIRs)) via Enterprise Geospatial Information Services (eGIS) to provide situational awareness and aid in operational effectiveness in real time. Serves as an expert in the use of the eGIS mapping application that depicts CBP resources and activities to facilitate situational awareness among all components of the CBP community. 25%

Database Analysis - Utilizes a variety of law enforcement information systems including but not limited to: Automated Targeting System, Targeting Framework, Intelligence Report System, and Intelligent Computer Assisted Detection (ICAD) to conduct data mining and analysis. Utilizes national databases to determine identity, noncitizenship, and removability of individuals in accordance with Immigration laws, rules and regulations. This includes identification of criminal violators under the Immigration and

Nationality laws, United States Code, and regulations subject to criminal prosecution and removal. Incumbent gathers and analyzes data collected throughout numerous databases to ensure a proper status determination is quickly and accurately made. Conducts real-time, rapid research through a wide assortment of databases and information systems to locate data pertinent to the timely development of tactical decisions made during mission planning and execution. Identifies and reports criminal history information, federal/state/local warrants, and driver's license information. Reports are conducted for subject identification, international travel associations, gang affiliations, and residence and vehicle associations to ensure officer safety in real time.
