Final Environmental Assessment and Draft Finding of No Significant Impact for the Proposed Dexter Elementary School Replacement

Fort Moore, Georgia

The United States Army Maneuver Center of Excellence, Directorate of Public Works, Fort Moore, Georgia, hereby announces the availability of the Final Environmental Assessment (EA) and Draft Finding of No Significant Impact (FONSI) for the Proposed Dexter Elementary School Replacement, Fort Moore, Georgia. These documents address the proposal to construct a new elementary school to address student capacity needs and facility requirements at Fort Moore. The proposed action encompasses building a new two-story building that is a maximum of I 16,500 square feet and has a design population of 600 students. The project site improvements would include a maximum of 120 parking spaces and a new outdoor play area for the students including three playgrounds, hardcourts for basketball, a bicycle trail, and open grassed field area.

The Final EA and Draft FONSI have been prepared in accordance with the National Environmental Policy Act of 1969 (42 US Code [USC] 4321 et seq.), the Council on Environmental Quality (CEQ) Regulations Implementing the Procedural Provisions of NEPA (40 Code of Federal Regulations [CFR] Part I 500-1508), and the Army NEPA Regulation (Environmental Analysis of Army Actions; 32 CFR Part 651). Publication of this notice begins a 30-day public review period.
