Lieutenant Colonel (LTC) Christopher (Chris) L. Upon completion of the Maneuver Captains Career Course, LTC Gilluly served Squadron Plans Officer, Rear Detachment Commander, Logistics Officer, and Headquarters and Headquarters Troop Commander, 4th Squadron, 73rd Cavalry Regiment, 4th Brigade, 82nd Airborne Division, Fort Bragg, North Carolina from 2009 to 2012; deploying in 2012 to Afghanistan for Operation Enduring Freedom as a Troop Commander in Maiwand and Zharey Districts in the Kandahar Province under Regional Command-South of the International Security Assistance Force. Following command, LTC Gilluly served as the Executive Officer to the XVIII Airborne Corps Assistant Chief of Staff, G3 from 2013 to 2014 at Fort Bragg, North Carolina. After completion of his Intermediate Level Education, LTC Gilluly served as Squadron Operations Officer then Executive Officer, 1st Squadron, 2nd Cavalry Regiment at Rose Barracks, Vilseck, Germany from 2015 to 2017, participating in numerous United States Army Europe and North Atlantic Treaty Organization multinational and bilateral training exercises, and deploying to Egypt as a part of the Multinational Force and

Observers peacekeeping mission from 2015 to 2016. After completing additional military education in strategic and operational planning at the School of Advanced Military Studies in 2018, LTC Gilluly served at Camp Humphreys, Republic of Korea as the Eighth United States Army, Assistant Chief of Staff, GS Plans, Strategy and Policy Planner and Deputy Director, Commander's Action Group for the 8th Army Commanding General. More recently, LTC Gilluly served with Army Futures Command as Experimentation Branch Chief at the Mission Command Center in Fort Leavenworth, Kansas, and then served as an Exchange Officer in the Australian Defense Force as an instructor at the Australian Command and Staff College for the past two years.
