

MICC Enhanced DCO COR Comprehension Training Instructions

Department of Defense minimum requirements for designation and training of CORs are found at [FAR 1.602-2](#), [DFARS 201.602-2](#) and [PGI 201.602-2](#). The PGI 201.602-2 references DoD standards as established in the [OUSD \(AT&L\) memorandum dated March 29, 2010, DoD Standard for Certification of Contracting Officer's Representatives \(COR\) for Service Acquisitions \(See Annex A\)](#).

The MICC Enhanced COR Training is a 16 hour face-to-face training equivalent to ACC COR Comprehension Training referenced in ACC PAM 70-1, Interim Army Contracting Command – Contracting Officer's Representative Policy Guide (See Annex B). Pursuant to Army Regulation 70-13; Management and Oversight of Service Acquisitions, as described in DFARS 201.602-2 and Deputy Secretary of Defense Memorandum, dated 22 August 2008, a properly trained COR shall be designated for acquisition of service contracts in support of Army requirements before contract award. This training, like all COR training, must be completed prior to nomination and appointment. MICC trained and certified instructors present the MICC Enhanced COR Training, primarily focusing on those duties designated to MICC appointed CORs.

A Defense Connect Online (DCO) version of the MICC Enhanced COR Training is available to train CORs when there is no MICC certified instructor available, or the potential COR is unable to travel TDY to take the course face-to-face. Taking into account the relevant circumstances, the MICC COR Training Manager retains the authority to determine in each instance if the DCO training medium is an appropriate substitute for the face-to-face training normally given by a certified trainer. Upon the COR completing the DCO training, they will notify the MICC COR Training Manager who will send the test electronically to them. There will be a time limit of one hour to complete the test. The MICC COR Training Manager will e-mail a certificate of completion to the COR upon the COR achieving the minimum passing score of 70. MICC Policy allows two attempts to achieve a passing score. In the event a prospective COR fails the second attempt, the entire COR training syllabus must be repeated. If the third test attempt is unsuccessful, the MICC COR Training Manager will contact the COR's supervisor to solicit administrative input.

1. Create a DCO account at <https://www.dco.dod.mil/>. System requirements are JAVA 1.6. This should already be installed on your computer. If it is not, contact your local IT computer support team and request they install the latest edition of the required java software. Creating an account is fairly simple and takes just a few moments.
