Please read all attachments and the email below before contacting the Warrior Training Center Rappel Master schoolhouse.

Attached is the WTC Form 100 and instructions for reporting to **Rappel Master Course at Fort Moore, Georgia**. More information about the Rappel Master Course in general, to include a copy of the course MOI, can be found attached to this email. It is the responsibility of each perspective student to read and familiarize his or herself with the student MOI prior to reporting for training.

**-Report Day** will be at **1600hrs on Saturday** on Camp Butler, Fort Moore. Students will check-in with the BN Staff Duty NCO at the front desk of **Building 4165**, then be given their barracks number (male or female). Dinner chow will be provided.

**-In-processing** will begin at **0655hrs** on Day 01 at **Building 4159** which is located on Camp Butler, Fort Moore. Soldiers who arrive late will only be entered into the course at the discretion of the course NCOIC. Students reporting for in-processing **MUST** be in OCPs or sister service equivalent and must have all required documentation and a black ink pen to write with. Students must also have a water source with them.

You must have the paperwork listed below completed and/or current in order to be in-processed:

- Orders (DA4187/DD1610)
- Current DA 705
- Current DA 5500/5501
- IMR Record printout from MEDPROS (PHA within one year of report date. HIV and immunizations must be current.)
- Completed, current FY WTC Form 100 (Attached to this email)
- COVID 19 Vaccination Card (or an approved exemption)

**-Meals** will NOT be provided outside of the specified course dates.

**-Lodging** will be provided for Soldiers arriving a day prior to In-processing day.

Linen will not be provided. **Students are responsible for bringing their own linen or sleeping bag.** For the Rappel Master Course students will be housed in open bay quarters.

**-Transportation:** The Warrior Training Center is a Mobile Training Team out of Fort Moore, GA and will not be providing transportation to or from the Air Assault course for students. Prior transportation coordination should be made through your organic organization.

**-Graduation Day Flights:** Graduation Day **flights must NOT be scheduled for any time prior to 1600.**  
**No exceptions.**

**-POVs:** POVs will be off limits to students during POI.

Soldier's driving more than 300 miles on graduation day will be released at the discretion of the Rappel Master NCOIC. Soldiers must submit an acceptable plan of action for traveling home in order to be released. Barracks will be provided for Soldiers staying after graduation for 1 night only.

As far as questions concerning TA-50 and packing list items, I understand that units issue different or

more up to date equipment. If the item you have is equivalent to the item on the packing list but is the newer or older issue, it will be accepted. Boots must be IAW DA PAM 670-1. If you have any questions after you have read all attachments, checked ATRRS and this email, you will contact your unit's schools POC and they will contact me. I will not respond to emails from individual students.
